CREDIT TERMS OF SALE

1. Until credit is approved by Envirolume, payment for products and services will be due by Customer at time of shipment.
2. Customer authorizes Envirolume to contact the provided bank and trade references, as well as any credit reporting agency, to discuss any credit or financial history information without further consent of or liability to the Customer, for the purpose of evaluating the Customer's credit worthiness at any time. All information obtained by Envirolume is held strictly confidential.
3. Any person engaging in a transaction on behalf of the Customer represents it is authorized to bind the Customer to the transaction and the terms contained herein.
4. Any invoice unpaid after (30) days beyond the due date will be subject to a 1.5% monthly service charge (18% annual percentage rate).
5. Customer agrees Envirolumes' acceptance of payments of less than full invoice amount shall not be construed as a waiver of Envirolumes' right to collect the remainder due.
6. Failure to pay invoices within approved payment terms may result in deliveries being suspended and the credit account being placed on hold.
7. Payments must be made by check or ACH (bank routing information provided upon request). A 3.5% fee will be applied to invoices paid by credit card unless payment is made at time of shipment. A \$35.00 fee will be assessed on all returned checks.
8. In the event of default and/or referral to a Third Party Collection Agency or Attorney, Customer agrees to pay all costs and fees associated with such services.
9. Customer shall notify Envirolume in writing at least thirty (30) days prior to any change of ownership. Envirolume may, regardless of the terms stated on the invoices, require all outstanding amounts be paid in full on demand upon change in ownership.
10. Envirolume reserves the right to alter or suspend credit at any time.
11. Electronic documents and electronic signatures will be deemed as originals and no transaction or agreement shall be denied legal effect solely because any portion thereof, including any signature, is in electronic form.
